2017 Membership Renewal Form

Please read carefully before signing. This is an agreement for release of liability, waiver of legal rights and an agreement not to sue.

1. I understand and acknowledge that activities conducted at the Boulder Rifle Club (BRC) including but not limited to shooting, archery, etc., are inherently dangerous and hazardous and that participation in such activities exposes me to a substantial risk of death, serious personal injury and damage to my property. I understand that such risk of death, injury and property damage is not limited to shooting activities and includes, but is not limited to, use of club equipment, lightning and the presence of uneven terrain and rattlesnakes on the property. I understand the nature of the dangers and risks involved in participating in BRC activities and voluntarily choose to do so, and expressly assume all risks and dangers of such activities whether KNOWN or UNKOWN, inherent or otherwise.
2. In consideration of being granted a membership in the BRC, the right to use the BRC and its facilities, and the services provided by the BRC, for myself and my spouse, legal representatives, heirs, successors and assigns, I release and discharge the BRC and its Directors, Officers, employees and members (the Released Parties) from all liability to me and my spouse, legal representatives, heirs, successors and assigns, for any and all claims, suits, demands, loss or damage, including, without limitation, reasonable attorney's fees, arising out of or relating to my participation in BRC activities, my presence at the BRC or my use of any of its facilities, on account of injury to me, including injury resulting in my death, or damage to my property, even when caused by the actual or alleged NEGLIGENCE of any one or more of the Released Parties, or caused otherwise.
3. As further consideration of membership, I agree not to sue the BRC or any of the Released Parties on account of injury to me, including injury resulting in my death, or damage to my property arising out of or relating to my participation in BRC activities, my presence at the BRC or my use of any of its facilities. By agreeing not to sue, I hereby waive any and all right I have, now or in the future, whether directly or indirectly, to commence or peruse any legal action, suit or other proceeding against any or all of the Released Parties arising out of or relating to my participation in BRC activities, my presence at the BRC or my use of any of its facilities.
4. As further consideration of membership, I agree to defend, indemnify and reimburse the Released Parties and hold the Released Parties harmless from any liability, suit, claim, demand, cause of action, loss or damage, including, without limitation, reasonable attorney's fees and costs incurred by any Released Party, arising out of or relating to my participation in BRC activities, my presence at the BRC or my use of any of its facilities, any breach by me of any agreement or obligation of mine under this agreement, or use of, or presence at, the BRC by my guests, including, without limitation, a member of my immediate family.
5. As further consideration of membership, I agree that any and all claims of any kind brought against the BRC shall be governed by the laws of the State of Colorado and that exclusive jurisdiction for the bringing of any such claim shall be in the District Court of Boulder County, Colorado.
6. I understand and agree that for any of my family members who are minors (under the age of 18) I as parent or legal guardian am signing this agreement on their behalf and all such minors are also bound by the terms of this agreement. I understand and agree that I am waiving certain legal rights on behalf of any such minors and that if I did not agree to this condition such minors would not be allowed to participate in any BRC activities or use any BRC facilities.
7. I understand and agree that any non-member guests who I bring to the BRC must agree to and sign the BRC's agreement for release of liability, waiver of legal rights and an agreement not to sue on behalf of themselves and any minor children who accompany them.
8. I understand and agree that the provisions of this Agreement shall be binding upon me and my spouse, legal representatives, heirs, successors and assigns. I understand and agree that this Agreement between me and the BRC is a contract and is binding to the fullest extent of Colorado law and that if any part of this Agreement is held to be unenforceable, the remaining parts shall be binding and enforceable.

I have carefully read this document which includes an assumption of risk, a release of liability, a promise not to sue and an indemnification agreement. I understand what it says. I am aware I am releasing certain legal rights.
